4. APPLICATION / LIMITATION:

- 4.1 As per Requirements of Regulations stated on the front page of this certificate.
- 4.2 The equipment fulfils the EMC requirements for installation on the Bridge and Deck Zone.
- 4.3 The equipment is not to be fitted in hazardous areas and refrigerated chambers.
- 4.4 Prior to fit on board, assessment of compatibility or connectability with fire alarm unit is to be performed.
- 4.5 Only Hardware and Software successfully tested together in compliance with the regulations as referred to in page one, according to the declaration of the manufacturer are covered by this certificate.
- 4.6 For above OC-VIEx Detector:

In case of installation in Hazardous Area, a type approved I.S barrier, is to be fitted in safe Area, to limit the electrical power on the detection line.

The detection line must be equipped with fire detectors and/or manual call points with an ATEX certification.

All intrinsically safe wiring shall be kept separate from non-intrinsically safe wiring.
